**Foreign citizens who DO NOT need visa for the entry on the territory of the Republic of Moldova** (for more information visit: [www.mfa.gov.md](http://www.mfa.gov.md))

The citizens of the following states, the holders of all the types of passports, do not need visas for the entry on the territory of the Republic of Moldova for a period of stay until 90 days, during six months from the moment of the first entry:

- a. the following member states of the European Union - Austria, Belgium, Bulgaria, Czech Republic, Cyprus, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Ireland, Italy, Latvia, Lithuania, Luxembourg, Malta, Netherlands, Poland, Portugal, Romania, Slovenia, Slovakia, Spain, Sweden, United Kingdom;
- b. Andorra, Australia, Canada, Chile, Croatia, Ecuador, Georgia, Holy See, Iceland, Israel, Japan, Liechtenstein, Malaysia, Monaco, New Zealand, Norway, Republic of Korea, San Marino, Swiss Confederation, Singapore, USA,;
- c. CIS member states: Armenia, Azerbaijan, Belarus, Kazakhstan, Kyrgyzstan, Russian Federation, Tajikistan, Ukraine and Uzbekistan.
